

#### Overview

Osceola Capital Management is a Tampa-based private equity firm that invests in lower middle market services companies. Our strategy is to partner with exceptional management teams and drive longterm value creation through a combination of strategic acquisitions, internal growth initiatives, and operational improvements. We offer a unique blend of operations and transaction experience to help support our management teams – principals of Osceola have served in C-suite positions of businesses they have founded, grown, and ultimately sold to private equity funds, and we have completed over 150 acquisitions as both private equity investors and operators. Osceola was founded in 2014 and has approximately \$400 million in assets under management. Osceola is currently investing out of Fund II (a \$200M fund) and is still actively supporting add-on acquisitions for platforms out of Fund I (a 2018-vintage \$125M fund). Since launching our first institutional fund in 2018, Osceola has completed 10 platform investments and over 90 add-on acquisitions.
